It was moved by Ms. Hook, seconded by Mr. Davis, and carried to approve the Minutes of the April 22, 2013 Disability Appeals Committee Meeting.

Ms. Smith noted the necessity of closed session for the purpose of reviewing the disability applications of Administrative Action Numbers: 11-D-63, 12-D-20, 11-D-89, 11-D-145, 12-D-09, 11-D-153, 07-D-55, 11-D-111, 11-D-104, 11-D-157, 11-D-155, 11-D-118, 11-D-100, 12-D-12, 12-D-15 and 12-D-73.

Approval is based upon the cumulative effect of the Claimant's multiple conditions.

Approval is based solely on the Claimant's cardiac condition. Ms. Hook abstained.
