At the meeting of the Administrative Appeals Committee, held on February 24, 2016, the following members were present: Ed Davis, Chair, Mary Helen Peter and Donna Shelton, Proxy on behalf of Thomas Stephens.

In addition, those present were Becky Stephens, KRS, Liza Welch, KRS, Joseph Bowman, KRS, Alan Hurst, KRS and Tracy Chambers, Recording Secretary.

It was moved by Ms. Peter, seconded by Ms. Shelton, and carried to approve the Minutes of the December 21, 2015 Administrative Appeals Committee Meeting.

Mr. Davis noted the necessity of closed session for the purpose of reviewing the administrative appeals of Administrative Action Numbers: 15-A-03, 15-A-05 and 15-A-16.

Following discussion in closed session, the Committee returned to open session, whereafter the following transpired.

It was moved by Ms. Shelton, seconded by Ms. Peter, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 15-A-03, to accept the Hearing Officer's Report, Findings of Fact, Conclusions of Law, and to require that claimant must repay the Agency the sum of \$176,831.70 representing all benefits he received in error during which he violated the retired-reemployed provisions of KRS 61.637 and 105 KAR 1:390.

It was moved by Ms. Peter, seconded by Ms. Shelton, and carried unanimously, that the Committee members having considered the record, including the Hearing Officer's Order Recommending Dismissal and any exceptions duly filed, in the case of Administrative Action Number: 15-A-05, to accept the Hearing Officer's Order Recommending Dismissal and to dismiss this action, as there being no justiciable controversy between the parties.

It was moved by Ms. Shelton, seconded by Ms. Peter, and carried unanimously, that the Committee members having considered the record, including the Hearing Officer's Order Recommending Dismissal and any exceptions duly filed, in the case of Administrative Action Number: 15-A-16, to accept the Hearing Officer's Order Recommending Dismissal and to dismiss this action, as there being no justiciable controversy between the parties.

There being no further business, the meeting was adjourned at 10:50 A.M., E.T. to meet on April 26, 2016 immediately following the Disability Appeals Committee meeting.
