

**MINUTES

At the meeting of the Disability Appeals Committee, held on January 20, 2021, the following members were present via live video teleconference due to SB 150, signed into law by the Governor on March 30, 2020, and Executive Order 2020-215 declaring a State of Emergency effective March 6, 2020 due to COVID-19: Keith Peercy, Chair, Campbell Connell, and Gordon Rowe, Proxy on behalf of Gerina D. Whethers.

In addition, those present were Erin Surratt, KRS, Liza Welch, KRS, Victoria Hale, KRS, Justin McNeil, KRS, Shaun Case, KRS, and Tracy Chambers, Recording Secretary.

It was moved by Mr. Connell, seconded by Mr. Peercy, and carried to approve the Minutes of the July 20, 2020 Disability Appeals Committee Meeting.

It was moved by Mr. Rowe, seconded by Mr. Peercy, and carried to approve the Minutes of the November 30, 2020 Disability Appeals Committee Meeting.

Mr. Case departed the meeting prior to entering closed session.

Mr. Peercy noted the necessity of closed session for the purpose of reviewing the disability applications of Administrative Action Numbers: 19-D-15, 19-D-32, 19-D-50, 20-D-13, 19-D-10, and 20-D-05.

Following discussion in closed session, the Committee returned to open session, whereafter the following transpired.
