The meeting of the Joint Disability and Administrative Appeals Committees, held on August 14, 2025, was called to order by Mr. Peercy at 9:30 a.m. E.T. The following members were present via live video teleconference: Keith Peercy, Chair, Dr. Crystal Miller, and Tommy McGraw.

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously to approve the Minutes of the June 16, 2025, Joint Disability and Administrative Appeals Committees Meeting.

Mr. Peercy noted the necessity of closed session for the purpose of reviewing the disability applications and administrative appeals of Administrative Action Numbers:

22-T-34, 22-T-62, 22-T-68, 22-T-69, 22-T-95, and 22-T-102

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously to enter closed session.

Following discussion in closed session, the Committees returned to open session, whereafter the following transpired.

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously, that the Committee members having considered the Administrative Record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-34, to adopt the Hearing Officer's Recommendation to Continue Claimant's non-hazardous disability retirement benefits, as modified in the Board Final Order, with a review in three (3) years.

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously, that the Committee

members having considered the Administrative Record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-62, to adopt the Hearing Officer's Recommendation to Continue Claimant's non-hazardous disability retirement benefits, as modified in the Board Final Order, with a review in five (5) years.

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously, that the Committee members having considered the Administrative Record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-68, to adopt the Hearing Officer's Recommendation to Continue Claimant's non-hazardous disability retirement benefits, as modified in the Board Final Order, with a review in three (3) years.

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously, that the Committee members having considered the Administrative Record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-69, to adopt the Hearing Officer's Recommendation to Continue Claimant's non-hazardous disability retirement benefits, as modified in the Board Final Order, with a review in five (5) years.

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously, that the Committee members having considered the Administrative Record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-95, to adopt the Hearing Officer's Recommendation to Remand this case to the Hearing Officer to correct issues as set forth in the Board Remand Order.

It was moved by Dr. Miller, seconded by Mr. McGraw, and carried unanimously, that the Committee members having considered the Administrative Record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-102, to adopt the Hearing Officer's Recommendation to Continue Claimant's non-hazardous disability retirement benefits, as modified in the Board Final Order, with a review in three (3) years.
