It was moved by Ms. Pendergrass, seconded by Mr. Connell, and carried unanimously, that the Committee members having considered the record, including the Hearing Officer's Order of Dismissal and any exceptions duly filed, in the case of Administrative Action Number: 20-D-47, to accept the Hearing Officer's Order of Dismissal, and to dismiss this action with prejudice. Furthermore, the Claimant's Motion to Reconsider the Hearing Officer's Dismissal, is hereby denied due to the Motion having been untimely filed.
