It was moved by Mr. Connell, seconded by Ms. Pendergrass, and carried to approve the Minutes of the October 25, 2021 Joint Disability and Administrative Appeals Committee Meeting.

Mr. Peercy noted the necessity of closed session for the purpose of reviewing the disability applications and administrative appeals of Administrative Action Numbers: 20-T-07, and 20-D-38.

It was moved by Mr. Connell, seconded by Ms. Pendergrass, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 20-D-38, to remand this case in order for the Hearing Officer to issue a new Recommended Order regarding whether the Claimant is entitled to disability retirement benefits.

There being no further business, the meeting was adjourned at 9:46 A.M., E.T. The Joint Committee deferred scheduling the next meeting until after the 2022 CERS and KRS Board and Committee Meeting schedules had been approved.
