At the special called meeting of the Kentucky Retirement Systems Board of Trustees held on December 22, 2022, the following members were present: Lynn Hampton (Chair), Prewitt Lane, David Adkins, Ramsey Bova, John Cheshire, Keith Peercy, and William Summers, V. Mr. Lane advised that the purpose of the meeting was to ratify the actions of the Investment Committee and to approve KRS' investments with the Real Return Investment Managers Ceres Farms, LLC, Maritime Partners American Rivers Fund, and Arctos Sprots Partners Fund II.

Chief Investment Officer, Mr. Steve Willer presented the real return search and recommendation summary with the KRS Board of Trustees. He advised that these three unique investments have a committed capital queue. Queue position is dependent on the timing of the subscription and market conditions, said Mr. Willer. He advised the Board of Trustees that the presented recommendations were the culmination of a competitive search process. Mr. Chiu, Deputy Chief Investment Officer, briefly presented the three opportunities and the driver of returns for each investment.
