At the meeting of the Joint Disability and Administrative Appeals Committees, held on February 23, 2022, the following members were present via live video teleconference: Keith Peercy, Chair, Betty Pendergrass, and Campbell Connell.

In addition, those present were Erin Surratt, KPPA, Liza Welch, KPPA, Victoria Hale, KPPA, Andrea Freadreacea, KPPA, Shaun Case, KPPA, Glenna Frasher, KPPA, Lisa Perry, KPPA, and Tracy Chambers, Recording Secretary.

It was moved by Ms. Pendergrass, seconded by Mr. Connell, and carried to approve the Minutes of the December 22, 2021 Joint Disability and Administrative Appeals Committee Meeting.

Mr. Case and Ms. Frasher departed the meeting prior to entering closed session.

Mr. Peercy noted the necessity of closed session for the purpose of reviewing the disability applications and administrative appeals of Administrative Action Numbers: 21-A-02, 20-T-15, 20-D-25, 21-D-07, and 21-D-09.

Ms. Pendergrass declared a conflict on Administrative Action Number: 21-D-09 and was placed in a waiting room and was not present during the discussion of that matter. Prior to going into open session Ms. Pendergrass returned to the meeting room.

Following discussion in closed session, the Committee returned to open session, whereafter the following transpired.

It was moved by Ms. Pendergrass, seconded by Mr. Connell, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 21-A-02, to accept the Hearing Officer's Report, as modified in the Board Final Order, and to affirm Kentucky Public Pensions Authority's determination that Claimant was not eligible to apply for disability retirement benefits.

It was moved by Mr. Connell, seconded by Ms. Pendergrass, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 20-T-15, to accept the Hearing Officer's Report, as modified in the Board Final Order, and to continue Claimant's disability retirement benefits, with a review in three years. Furthermore, the Boards hereby order that the last page of Exhibit 72 is stricken from the Administrative Record as it does not pertain to Claimant.

It was moved by Ms. Pendergrass, seconded by Mr. Connell, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 20-D-25, to accept the Hearing Officer's Report, as modified in the Board Final Order, and to deny Claimant's application for disability retirement benefits.

It was moved by Mr. Connell, seconded by Ms. Pendergrass, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 21-D-07, to accept the Hearing Officer's Report, as modified in the Board Final Order, and to deny Claimant's application for disability retirement benefits.

It was moved by Mr. Peercy, seconded by Mr. Connell, and carried by a majority, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 21-D-09, to accept the Hearing Officer's Report, as modified in the Board Final Order, and to deny Claimant's application for disability retirement benefits. Ms. Pendergrass abstained.

There being no further business, the meeting was adjourned at 10:04 A.M., E.T. to meet on April 18, 2022 at 9:30 A.M., E.T.
