It was moved by Ms. Eaves, seconded by Dr. Carver, and carried unanimously to approve the Minutes of the May 30, 2024, Joint Disability and Administrative Appeals Committees Meeting.

Mr. Powell noted the necessity of closed session for the purpose of reviewing the disability applications and administrative appeals of Administrative Action Numbers:

It was moved by Dr. Carver, seconded by Ms. Eaves, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 20-D-19, to accept the Hearing Officer's Recommended Order on Remand, as modified in the Board Final Order, to Deny the Claimant's application for non-hazardous disability retirement benefits.

It was moved by Dr. Carver, seconded by Ms. Eaves, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-03, to accept the Hearing Officer's Recommended Order, as modified in the Board Final Order, to Continue the Claimant's non-hazardous disability retirement benefits, with a review in three (3) years.

It was moved by Dr. Carver, seconded by Ms. Eaves, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-29, to accept the Hearing Officer's Recommended Order on Remand, as modified in the Board Final Order, to Continue the Claimant's non-hazardous disability retirement benefits for the specific conditions listed, with a review in three (3) years, and to discontinue Claimant's non-hazardous disability retirement benefits on the remaining conditions as listed in the Boards' Final Order.

It was moved by Ms. Eaves, seconded by Dr. Carver, and carried unanimously, that the Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-48, to Remand this case to the Hearing Officer to make a determination regarding whether the Claimant has met his burden of proof after making corrections to the Findings of Fact and Conclusions of Law as set forth in the Boards' Final Order.

It was moved by Dr. Carver, seconded by Ms. Eaves, and carried unanimously, that the

Committee members having considered the record, including the recommended order and any exceptions duly filed, in the case of Administrative Action Number: 22-T-57, to Reject the Hearing Officer's Recommendation and instruct staff to rewrite the final order continuing Claimant's non-hazardous disability retirement benefits with a review in five (5) years.
