

**MINUTES OF MEETING  
COUNTY EMPLOYEES RETIREMENT SYSTEM  
BOARD OF TRUSTEES MEETING  
MARCH 9, 2026, AT 2:00 P.M. ET  
VIA LIVE VIDEO TELECONFERENCE**

At the Meeting of the County Employees Retirement System Board of Trustees held on March 9, 2026, the following members were present: George Cheatham, Dr. Patricia Carver, Michael Foster, Jim Tony Fulkerson, Dr. Merl Hackbart, William O'Mara, Tommy McGraw, and Steven Webb. Staff members present were CERS CEO Ed Owens III, Ryan Barrow, Erin Surratt, Michael Lamb, Michael Board, Odette Gwandi, Leigh Ann Davis, Nathan Goodrich, D'Juan Surratt, Steve Willer, Connie Davis, Brian Caldwell, Connie Pettyjohn, Shaun Case, Sherry Rankin, and Mary Hill. Others present included Eric Branco with Johnson, Branco & Brennan, LLC; Lealan Miller, Kellie Bergey, and Roger Alfaro with Eide Bailly; David Lindberg, Chris Tessman, Craig Morton, and John Patterson with Wilshire Advisors, LLC; and Gabe Hellinger and Joe Cowles with Humana.

1. Mr. Cheatham called the meeting to order.
2. Mr. Branco read the *Opening Statement*.
3. Ms. Rankin did the *Roll Call* and Mr. Cheatham introduced the agenda item *Public Comment*. (Video 00:05:59 to 00:06:23). Ms. Rankin indicated there were 601 public comments submitted, to be addressed in the Chairman's Corner portion of the meeting.
4. Mr. Cheatham introduced agenda item *Approval of Minutes – November 10, 2025; December 1, 2025; and February 4, 2026*. (Video 00:06:27 to 00:08:21). Mr. Fulkerson made the motion to approve the minutes from the meeting held on November 10, 2025, as presented. Mr. McGraw seconded the motion and the motion passed unanimously. Dr. Hackbart made the motion to approve the minutes from the meeting held on December 1, 2025, as presented. Mr. Fulkerson seconded and the motion passed unanimously. Mr. O'Mara made the motion to

approve the minutes from the meeting held on February 4, 2026, as presented. Mr. Fulkerson seconded and the motion passed unanimously.

5. **Chairman's Corner.** (Video 00:08:25 to 00:11:39). Mr. Cheatham made a statement addressing the many public comments received in support of House Bill ("HB") 406 and stated that the CERS Board members appreciate the engagement and want to ensure members that their comments do not fall on deaf ears. While lobbying and legislation are not part of the Board's responsibilities, the Board has a duty to "faithfully implement the law as enacted." As such, the Board has been in discussions about how this proposed legislation will be implemented, should it be made law. He stated that the CERS Board is here to represent the members' best interests going forward.

Mr. Cheatham then requested that the public comments be made part of the official record of the meeting.

6. Mr. Cheatham introduced agenda item **External Audit Reports.** (Video 00:11:43 to 00:21:38). Connie Davis introduced Lealan Miller and Kellie Bergey from Eide Bailly to briefly discuss the GASB 68 and GASB 75 Proportionate Share Audits for CERS. Mr. Miller introduced Roger Alfaro as part of the audit team and thanked KPPA staff for their assistance getting them the information they need to perform the audits. He briefly explained their testing and review process of the Schedules and pension plans for fiscal year ("FY") ending June 30, 2025. He stated that there were no adverse findings and reported a clean audit. After Mr. Miller's presentation was paused for questions, Mr. Cheatham requested to have employer reports categorized alphabetically by name rather than simply using the employer numbers for ease of reference. Mr. Miller agreed to have subsequent reports categorized this way.

Mr. Cheatham asked for a motion to accept the CERS draft proportionate share audits, as presented, and to forward them to the KPPA Board for publication. Mr. Webb made the motion and Mr. Fulkerson seconded. The motion passed unanimously. The Eide Bailly representatives left the meeting after this vote.

7. Mr. Cheatham introduced agenda item ***Joint Retiree Health Plan Committee Report***. (Video 00:22:05 to 00:33:59). Dr. Carver introduced Connie Pettyjohn to give an overview of the Joint Retiree Health Plan C meeting held on February 12, 2026, including Humana's member satisfaction survey regarding the retiree health plans and some formulary changes to be implemented in the coming year. Ms. Pettyjohn also discussed call center, virtual appointment and in-person appointment numbers. Mr. Cheatham asked for a clarification on some figures regarding increased health care premiums for retirees and Ms. Pettyjohn explained that the increased costs are absorbed by CERS for members receiving 100% paid benefits and that the actuarial analyses are available and presented each year at the committee meeting held in September.

Mr. Cowles explained the increase in premiums were caused by a benefit enhancement required by the Centers for Medicare & Medicaid Services ("CMS"). He stated Humana is waiting for the final rate book due in early April before working on renewal with KPPA staff.

8. Mr. Cheatham introduced agenda item ***Finance Committee Report***. (Video 00:34:06 to 01:57:43). Mr. O'Mara introduced Mr. Lamb to give an update on the Finance Committee Quarterly Meeting held in February. Mr. Lamb provided some details about the Finance Committee Report, including Fiduciary Net Position and the CERS Contribution Report. There was some difficulty hearing Mr. Lamb's presentation so he stepped out of the meeting to reconnect in a different location. While doing so, Mr. O'Mara introduced Mr. Surratt to give an update on Hazardous Duty Requests.

Mr. Surratt stated that employers have submitted questionnaires, job descriptions, and all requests were reviewed to ensure they met the statutory requirements for hazardous duty classification. He highlighted a few positions with retroactive dates and explained they are a result of the ERCE team discovering inaccurate reporting by employers of some positions and they are requesting reclassification to ensure accurate reporting. Mr. Surratt emphasized that CERS has been receiving hazardous duty contributions for these positions and the changes are simply for accurate reporting. At this time, Mr. Cheatham asked for a motion to ratify the

Finance Committee's Approval of the Hazardous Duty Coverage requests as presented. Mr. O'Mara made the motion and Mr. Fulkerson seconded. The motion passed unanimously.

Mr. Lamb rejoined the meeting to resume his presentation on the CERS Contribution Report. Mr. Cheatham asked Mr. Lamb to go into more detail about the reciprocity with the Teacher's Retirement System ("TRS") regarding members' health insurance. Mr. Lamb explained that KPPA is in the early process of developing a memorandum with TRS to guarantee more timely payments that are due to the systems administered by KPPA. He then briefly discussed the Budget-to-Actual Summary Analysis, the Hybrid Allocation Summary, and the interest earned through J.P. Morgan accounts.

Regarding past-due balances owed to CERS, Mr. Lamb presented a report on the top ten (10) employers with outstanding contributions and a report on penalty invoices. He highlighted the Elliott County Ambulance Service ("ECAS") and provided a history of missing reports in their account due to changes in ECAS personnel and ongoing non-compliance. After making requests for the missing records, the KPPA Legal team was consulted in late 2023 to enforce compliance. Payroll records recovered by Legal were utilized to determine the contribution amounts for some of the outstanding reports and ECAS continued to be non-compliant in submitting. Mr. Lamb reported that ECAS is now timely reporting and paying contributions, but a large outstanding balance remains.

Mr. Cheatham asked for some clarification regarding the timeline of missing reports and if there have been retirees that claimed service at ECAS during the period of noncompliance. Mr. Lamb explained the retirement application process that is required by any member seeking to retire from any of the systems, including reviewing and verifying months of service credit and the contributions associated with that credit. If there are no contributions recorded within the system, the retiree does not receive any benefits until contributions are made. KPPA also employs a post-retirement audit done on members' accounts to further verify correct contributions and payments. Ms. Surratt further explained that as long as a member meets the eligibility criteria, they are able to retire but KPPA staff will run audits to ensure contributions

have been made. If these contributions are withheld from the employee's pay but not remitted to the system(s), the employer will be responsible for paying those contributions.

To answer Mr. Webb's question about the overdue reports, Mr. Lamb further explained that if employers do not submit their reports, there is no invoice generated for billing. He stated that KPPA staff have recently implemented a Task Force to more efficiently uncover these discrepancies between employers and their reporting so those accounts do not fall behind. Additionally, a new process is being deployed to average employers on an ongoing basis in order to catch these discrepancies. Mr. Lamb acknowledged that this is an ongoing issue but KPPA staff are committed to continuing improvement and the development and implementation of processes to do so.

There was additional discussion regarding the retirement process for a member, the processes by which service credit discrepancies are found, and the internal process used to calculate invoices for non-compliant employers. Mr. Lamb and Ms. Surratt also provided an overview of the Metcalfe Health Care Center cessation agreement and the reports and invoices contained therein. Mr. Lamb again addressed concerns about untimely employer reporting by explaining the processes KPPA is implementing to discover these discrepancies in reporting and payment. Mr. Cheatham requested a memorandum to be distributed among the Trustees explaining the new plans and processes that will be deployed in the near future. Mr. Lamb stated that he hoped to have that ready and distributed in a few weeks.

9. ***Optional Break*** (Video 01:58:23 to 02:07:10).
  
10. Mr. Cheatham introduced agenda item ***Investment Committee Report***. (Video 02:07:24 to 02:49:41). Dr. Hackbart gave a brief summary of the Investment Committee meeting held on February 25, 2026 and stated there were no items currently requiring board review and ratification. He then introduced Mr. Willer to discuss the Investment Cost Efficiency Services Request for Proposal ("RFP"). Mr. Willer gave a brief update on the RFP process and how his staff reviewed and vetted the responsive entities to reach their recommendation which will be presented in a special called Investment Committee meeting at a later date.

Mr. Willer then reported on the Pensions Portfolio Performance and noted that most portfolios are either meeting or outperforming benchmarks. He also discussed significant savings on management fees renegotiated by Joe Gilbert within the last year. Regarding market trends, he highlighted recent geopolitical events leading to some uncertainty and volatility, but stated that investment staff continue to monitor the situation. Mr. Lindberg agreed that diversification and rebalancing are key to weathering market volatility.

Mr. Lindberg introduced Mr. Patterson from Wilshire to discuss the Private Equity Pacing Strategy previously presented at the February 25<sup>th</sup> Investment Committee meeting, including benefits, critical elements, and CERS considerations in its rationale and implementation. He went on to explain the pacing strategy Wilshire proposed to meet and maintain target asset allocation to private equity. Following the presentation, there was a brief discussion about the possible performance of the private equity plan compared to the strategy currently in place. It is agreed that KPPA investment staff and the Board of Trustees will work with Wilshire to determine the best avenues to pursue.

11. Mr. Cheatham introduced agenda item **CEO Report**. (Video 02:49:48 to 02:50:33). Mr. Owens stated that his report can be found in the Board Book and opened the floor for questions but there were none.
12. Mr. Cheatham introduced agenda item **KPPA Report**. (Video 02:50:35 to 02:55:07). Mr. Barrow gave a brief update on new KPPA team members, upcoming Trustee training opportunities, and current legislation impacting KPPA making its way through the legislative process. Additionally, he highlighted the recent employee survey and offered several kudos for team members who continue to provide both KPPA employees and retirees with excellent service.
13. Mr. Cheatham introduced agenda item **Closed Session**. (Video 02:55:21 to 02:56:07). Mr. Branco made a brief statement about needing to go into a closed session and Mr. Foster made the motion to enter closed session. Mr. Webb seconded, and the motion passed unanimously.

## ***Closed Session***

Coming back into open session, (*Video - Part 2 - 00:00:15 to 00:01:42*), Mr. Cheatham requested a vote to come out of closed session. Mr. Cheatham stated that no action was taken within closed session discussions. He then requested a motion to authorize Mr. Branco to move forward with the Kentucky River Regional Jail litigation as outlined in the closed session. Mr. Foster made the motion and it was seconded by Mr. McGraw. The motion passed with Mr. O'Mara abstaining.

14. ***Other Business*** (*Video - Part 2 - 00:01:44 to 00:06:05*). Mr. O'Mara presented a Resolution for Cooperation between the Boards and management teams to review items before they are introduced for action in order to facilitate best outcomes for retirees. He then made a motion to adopt the Resolution for Cooperation. There was no second so it did not go to a vote. Mr. Cheatham stated that he did not want to give the impression that cooperation is not a goal for CERS, but there are issues that are within each Board's purview that may not be pertinent to the others. Mr. O'Mara clarified that is why the Resolution has been presented to all three (3) boards.
  
15. Mr. Cheatham suggested reconvening at the CERS Annual Board Meeting on April 15, 2026 and removing the regularly scheduled meeting on April 13. There being no further business, Mr. Cheatham requested a motion to ***adjourn***. Mr. Webb made a motion to adjourn and Mr. McGraw seconded the motion. The motion passed unanimously.
