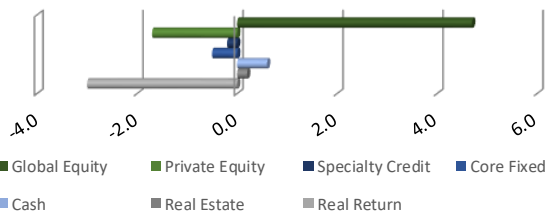

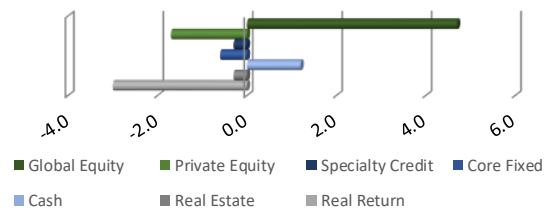

CERS-HAZ PEN Relative Weights

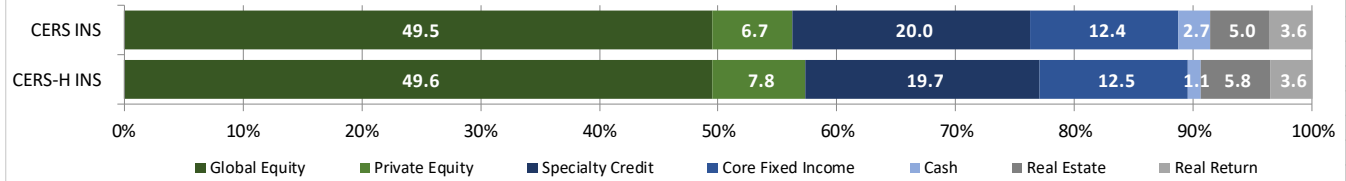

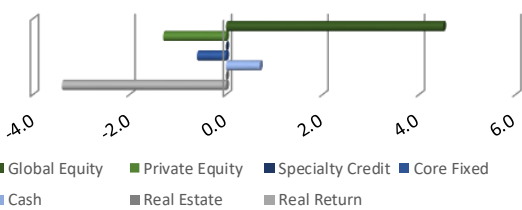
