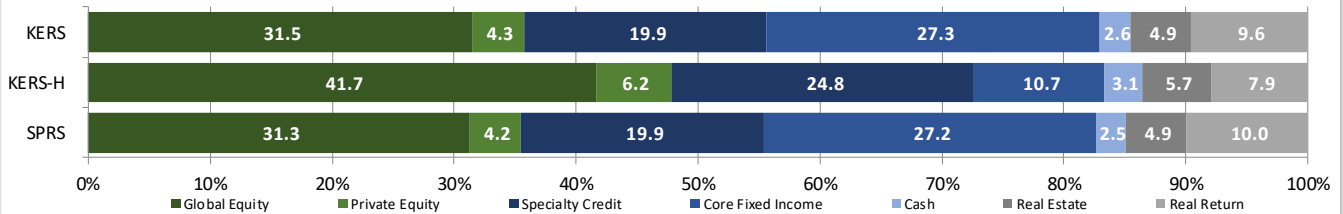

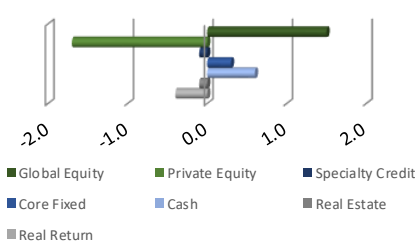

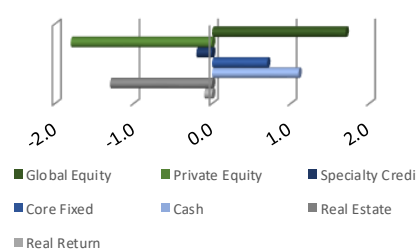

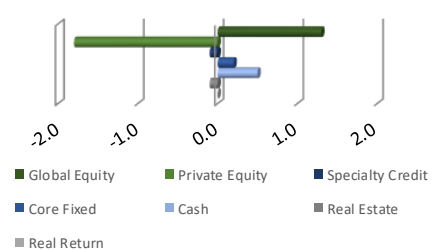
KERS PEN Relative Weights

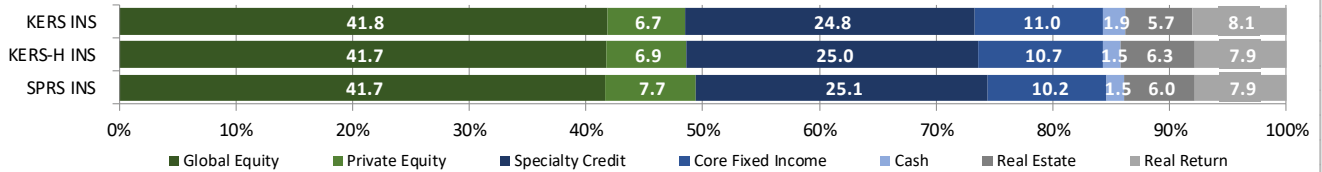

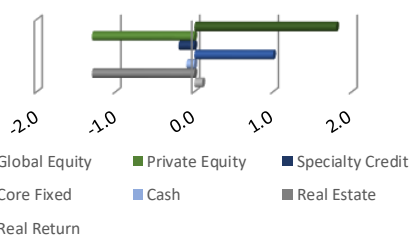

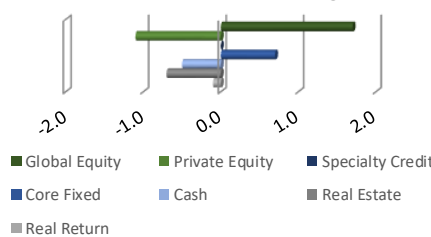
